## *Construction 5.0 Dropbox Summary*

### In general

- Construction is **slow to change** but **Covid-19 crisis** might **accelerate digitalization** and **better productivity**.
- **Sustainability** must be **at the heart of** the post Covid-19 **recovery**
- Need to strengthen an **inclusive, resilient and interoperable digital infrastructure**.
- Comparisons with China are made. Seen as more advanced in **technology** and **fast in execution**.

### On construction worksites

- **Social distancing technology** by retrofitting already existing technologies.
- **Facilitate remote work:** Initiate a complete inventory of digital tools
- Promote the use of **BIM**.

# REVIEWED OBJECTIVES

## Changes induced by COVID-19

- Digitalization is occurring faster than before.
- Post-pandemic stimulus can create jobs and help the climate.



## Adaptation of new and digital technologies
