According to the OECD and UN Habitat, "Urbanization is one of the megatrends driving global transformation. Around the world, cities are serving as engines of national economic growth and development. However, many cities are below 2015 baselines on some targets related to urban resilience, such as the number of people and services affected by natural disasters, sanitation and hygiene, and the number of refugees. Access to housing also remains a challenge, given that the total number of slum dwellers in 2022 was 130 million higher than in 2015". [...] "While there are a number of factors that can explain poor progress, including post COVID-19 pressures on public finances, a critical factor is often limited coordination across different levels of government and policy areas, in particular to manage trade-offs (for example, when allocating resources between short-term needs and long-term goals), whilst also maximizing potential synergies¹."

Building Resilience and Promoting Adequate, Inclusive and Sustainable Housing. Since 2018, UN-Habitat and the Organization for Economic Cooperation and Development (OECD) have developed the Global State of National Urban Policy reports as part of a joint National Urban Policy Programme (NUPP) providing a global monitoring through a comparative lens.
